TERMS AND CONDITIONS OF HIRE

If the hirer is in any doubt as to the meaning of the following, a representative from Party Time Grimsby should immediately be consulted.

THE HIRER will, during the period of the hiring, be responsible for the supervision of the equipment, its care, safety from damage however slight of any sort, and the behaviour of all persons of all ages using the equipment whatever their capacity, including proper supervision of children to ensure children under school age use the equipment separately to older children or adults. It is the responsibility of the person who is hiring the bouncy castle to ensure that all possible steps are taken to avoid injury to users or damage to the bouncy castle. A responsible adult must closely supervise the bouncy castle at all times. No adults are allowed on the bouncy castle unless you have hired an adult bouncy castle. All bouncy castles have an age limit specified. It is strictly prohibited for both children and adults to be on the bouncy castle at the same time. If children are on the bouncy castle then no adults are allowed on the bouncy castle and vice versa. Always ensure that the bouncy castle is not overcrowded, and limit numbers according to the age and size of children using it. It is advised that children of mixed ages should not use the bouncy castle at the same time. Do not allow children or adults to become boisterous, push, collide, fight or behave in a manner likely to injure or cause distress to others. Climbing, hanging or sitting on walls or beams of the bouncy castle is dangerous and must not be allowed. Do not allow anyone to bounce on the front safety step as a child could easily bounce off the step and get hurt. The step is there to assist users in getting on or off. Ensure that no one with a history of back or neck problems is allowed on the bouncy castle as indeed any person who is feeling unwell or taking medication. Please warn children of the tie down points (if appropriate) and make the area behind the unit, where the electrical blower is sited, out of bounds for children. The bouncy castle should not be used if it becomes wet on the jumping area. If no shower cover is fitted and in the event of rain, the bouncy castle should not be used. In the event of heavy rain, it is strongly recommended that the bouncy castle be switched off. Should the equipment fail for any reason, please ensure all users get off the bouncy castle immediately. No unauthorised person should move the bouncy castle or tamper with the electrical equipment. The hirer shall be deemed to have inspected the equipment and to have agreed that it is supplied in good condition unless he/she brings to the attention of Party Time Grimsby when it is set up and checked by the hirer when coming in to possession of the equipment any faults noted by the Hirer. The inflatable must be returned in an acceptable condition, i.e. clean, unsoiled and undamaged. If it is badly soiled or damaged the hirer will be expected to pay an additional charge to cover the cleaning costs and our loss of earnings if left unusable.

The hirer shall not use the equipment for any purpose other than that described in the hiring agreement, and shall not sub-hire or use the equipment or allow the equipment to be used for any unlawful purpose or in any unlawful way, nor allow anyone onto the equipment wearing shoes, spectacles, carrying sharp objects, keyrings, metal studded clothing or any other similar items which could cause damage to others or the equipment. No food or drink is to be taken onto or consumed on the equipment. No smoking or barbecues on or near the bouncy castle. No pets to be allowed on or near the bouncy castle. No party poppers, coloured streamers or silly string should be taken, thrown or sprayed onto the equipment, these materials permanently stain the material and the hirer will be liable to compensate Party Time Grimsby in the event of damage.

MAXIMUM AGE allowed to use this equipment is listed below, failure to observe this limit at any time during the hire period will render the hirer liable for associated repair costs.

THE HIRE PERIOD unless otherwise agreed is from delivery until 18.00 Hrs or after at the discretion of Party Time Grimsby any obstruction by the hirer or their guests causing unnecessary delay will be charged at £35 per hour or part of, this also applies where ball pit balls are not bagged and ready for collection

PUBLIC LIABILITY INSURANCE is excluded in its entirety following any claim or injury to any third party or employee whether directly or indirectly related to the use of drugs and/or alcohol. Party Time Grimsby excludes any liability or injury loss or damage caused to any person using the equipment contrary to the terms and conditions of this contract. Any claim is subject to an excess issued by our insurer which the hirer concerned would be liable for and payable in advance.

CONDITIONS OF HIRE FOR HIRERS OF RODEO MULTI RIDE / ULTIMATE WIPEOUT
The equipment will only be operated by our trained staff. The equipment will only be set up if there is a clear area to do so. We require a clear entrance at least 33" in width to transport the Multi ride in to position

All riders must be over the height of 1.2 metres or a minimum of 10 years of age. Only one rider is allowed at a time The equipment if used outdoors will not be used when raining, if it rains it will be switched off and covered until it stops. A small marquee can be provided at a cost of £50, this should be arranged in advance. No persons with medical conditions, which may put them at risk of injury (e.g. brittle bone disease or temporary injuries) to use the equipment. You are advised to have first aid facilities on site. A responsible adult must supervise any children on the equipment at all time. Riders should hold the rope only and must not hold onto the horns at any time.

Riders should sit upright at all times. Spectators must not lean against the surround and stay at least 2ft from the sides. Do not allow toys or objects to be taken on to the equipment as they may cause injury if fallen on or could puncture the equipment. Staff are there to operate the ride safely if they feel this is not possible they will stop the ride until safety is restored. This decision will be final. Staff will not tolerate any verbal abuse. Power for this equipment is to be supplied by you unless otherwise arranged. A Normal 13amp supply will be required. All foot wear, jewellery and spectacles must be removed before entering the ride. The equipment must be kept clean of mud etc. No food, drink, party poppers or silly string to be taken on the equipment cleaning charges may apply.

ALL USERS OF THESE RIDES DO SO AT THEIR OWN RISK.

YOU WILL FALL OFF THE MULTI RIDE. YOU WILL BE KNOCKED OVER ON THE ULTIMATE WIPEOUT.
